1. Eligibility: The Every Man Jack Sweat Equity Sweepstakes ("Sweepstakes") is open only to U.S. citizens and lawful permanent residents who are currently physically located in, and legal residents of, one of the fifty (50) United States or the District of Columbia (excluding Guam, Puerto Rico, and all other U.S. territories and possessions). All entrants must be at least eighteen (18) years of age (or the age of majority in their jurisdiction of residence) at the time of entry. Entrants must have either a valid Social Security number or a valid U.S. Individual Taxpayer Identification Number. Employees of Presidio Brands, Inc. dba Every Man Jack ("Sponsor"), Lunar Solar Group, LLC., Enteractive Solutions Group, Inc. ("Sweepstakes Administrator"), the advertising or promotion agencies, those involved in the production, development, distribution, implementation or handling the Sweepstakes, any agents acting for the above entities, their respective parent companies, officers, directors, subsidiaries, affiliates, service providers, prize suppliers, assigns, or any other person or entity associated with the Sweepstakes (collectively "Sweepstakes Entities") are ineligible to enter the Sweepstakes. Immediate family members (i.e., a spouse, domestic partner, child, sibling, or parent) and/or any person, whether related or not, living in the same household of an individual affiliated with a Sweepstakes Entity are also ineligible to enter the Sweepstakes.

2. Sweepstakes Period: For all purposes of this Sweepstakes, the Sponsor's computer is the official clock, and all times refer to Pacific Time ("PT"). The Sweepstakes begins on September 1, 2026 at 12:01 AM PT and ends on October 15, 2026 at 11:59 PM PT ("Sweepstakes Period").

3. How to Enter: There are nine (9) ways to enter:

a. **Join The Challenge:** In order to participate, entrants must first be registered at <http://everymanjack.com/pages/sweat-equity-sweepstakes> ("Hub"). Registration information includes: email address ("Entry Information"). Entrants can only register and participate in the Sweepstakes under one (1) email address. Once an email address has been registered by an entrant, that email address cannot be used by any other person at the Hub. Only the entrant registered under a particular email address with Sponsor may participate in the Sweepstakes. Entrants will receive one (1) join the challenge entry ("Join the Challenge Entry"). Limit one (1) Join the Challenge Entry per person.

b. **Add Your Instagram Handle:** Entrants will receive five (5) Instagram Handle Entries ("Instagram Handle Entry") by providing their Instagram handle in the Hub. Limit five (5) Instagram Handle Entry per person. Providing your Instagram handle is optional. Entrants will not be able to participate in Instagram entry activities without providing their handle.

c. **Follow Us on Social:** Follow Every Man Jack on Instagram (<https://www.instagram.com/everymanjack/>), TikTok (<https://www.tiktok.com/@everymanjack#>) and X (<https://x.com/everymanjack>) and receive five (5) social media follow entries ("Social Media Follow Entry") for each social media account followed. Limit up to fifteen (15) Social Media Follow Entries per person.

d. **Reshare our Post:** Entrants must follow the required instructions to reshare the designated content from the Hub and will receive twenty five (25) reshare entries ("Reshare Entry"). Each reshare must include the #sweatequitysweepstakes and tag @everymanjack. Limit one (1) reshare and twenty five (25) Reshare Entries per person.

e. **Nominate by Text or Email:** Entrants nominate someone with whom he/she has an existing relationship, he/she knows personally and to whom a nomination would not be considered spam, and who

meets the eligibility requirements for the Sweepstakes as described in section 1 above by sending them a text or email invitation via the Hub. Click “Earn Nominations” at the Hub for more details. The Entrant must include why they are nominating the person. This will generate a unique link the Entrant can send to the nominee. Entrants will receive fifty (50) email nomination entries (“Nomination Entry”) per nomination when the link is clicked on by the nominee. Limit up to five (5) nominations/two hundred fifty (250) Nomination Entries per person. Nominee will receive fifty (50) email nominee entries (“Nominee Entry”) by clicking on the link to enter the Sweepstakes or signing in to their existing account. Person can be nominated up to five (5) times. Limit up to two hundred fifty (250) Email Nominee Entries per person.

f. **Nominate on Social:** Entrants can publicly nominate someone through Instagram by publishing a post on their feed. The post must be of the nominator explaining why the nominee deserves recognition and tag @everymanjack, tag the nominee and include the hashtags #sweatequitysweepstakes and #nominate. Click “Earn Nominations” at the Hub for more details. A successful publication of a post results in fifty (50) Instagram nomination entries (“Social Nomination Entry”). Limit up to five (5) nominations. Limit of two hundred fifty (250) Social Nomination Entries per person. An entrant may only nominate someone with whom he/she has an existing relationship, he/she knows personally and to whom a nomination would not be considered spam, and who meets the eligibility requirements for the Sweepstakes as described in section 1 above. If the nominee’s tagged handle is already registered for the sweepstakes, they will automatically receive fifty (50) Instagram nominee entries (“Social Nominee Entry”). If they are not registered, the Sponsor will DM the nominee a link to the Hub. When the nominee registers, signs in and adds their Instagram handle, nominee will receive fifty (50) Instagram nominee entries. Person can be nominated up to five (5) times. Limit up to two hundred fifty (250) Social Nominee Entries per person. Each Social Nomination Entry will be approved by the Sponsor before it may appear in a community feed and the Social Nomination Entries are applied to the entrant’s total entry count.

g. **Buy Every Man Jack Deodorant & Upload Receipt:** Purchase Every Man Jack deodorant: Entrants must purchase 48H Sweat Control Antiperspirant or All-Day Aluminum-Free Deodorant from everymanjack.com, or any retailer where Every Man Jack deodorants are sold during the Sweepstakes Period and upload their receipt to the Hub to receive one hundred (100) purchase entries (“Purchase Entry”). See Hub for more details. Limit one (1) purchase per person per week. Limit of seven hundred (700) Purchase Entries per person.

h. **No Purchase Necessary Entry:** To enter without a purchase access the alternate method of entry (AMOE) website at <https://a.cstmapp.com/p/1018872> (“AMOE Website”) during the Sweepstakes Period. Then entrants must submit the following information: first name, last name, email address, and phone number (“AMOE Entry Information”). After completing and submitting the AMOE Entry Information, said entrant will then receive one hundred (100) AMOE entries into the Sweepstakes (“AMOE Entry”). Limit of one hundred (100) AMOE Entries per person/week. Limit of seven hundred (700) AMOE Entries per person.

i. **Show Us How You Put in the Work on Social:** Entrants can post an original video showing themselves “Putting in the Work” in Instagram. Video cannot contain any music. Post must include the #sweatequitysweepstakes and tag @everymanjack. Entrants will receive two hundred (200) Put in the Work entries (“Put in the Work Entry”). Limit of two hundred (200) Put in the Work Entries per person. The first five hundred (500) entrants who post an original video showing themselves “Putting in the Work” on Instagram will win a community prize (see section 4 for details).

All social media entries must include the Hashtag to be valid. An entrant’s social media account must be set to “Public” for their participation to be included; entrants who have an account set to “Private” cannot participate. Entrants must provide their Instagram handle in the Hub in order to receive any of the Instagram related Entries. If an entrant does not already have the applicable social media account, he/she can create one for free online or by going to either the App Store or Google Play and downloading the App, which is free, to his/her mobile device. This Sweepstakes is in no way sponsored, endorsed, administered by, or associated with Instagram, Facebook, X, TikTok, and YouTube, and each social media platform is

completely released of all liability by each entrant in this Sweepstakes. Entrants can only participate in the Sweepstakes under one (1) social media account per platform.

Join the Challenge Entries, Instagram Handle Entries, Social Media Follow Entries, Reshare Entries, Nomination Entries, Nominee Entries, Social Nomination Entries, Social Nominee Entry, Purchase Entries, AMOE Entries and Put in the Work Entries, collectively entries (“Entry”) must be received by 11:59 PM PT on October 15, 2026. All required Entry Information must be completed in full, be current, accurate, and valid. The Entry Information must match the information of the entrant that completed the act of physically entering the Sweepstakes. Any social media account used to enter the Sweepstakes must belong to the person that completes the act of physically entering the Sweepstakes. By participating each entrant confirms the accuracy and veracity of the statements and information contained therein. Proof of submitting an Entry will not be deemed by the Sponsor as proof of entry into the Sweepstakes. Any attempt by an entrant to obtain more than the stated number of Entries by using multiple/different email addresses, identities, registrations, logins, AI generative technology, multiple accounts per social media platform, or any other methods other than as described herein, including, but not limited to, commercial contest/sweepstakes subscription notification and/or entering services, will void that entrant’s Entries and that entrant may be disqualified. If entrants use a web-enabled mobile device to participate, data rates may apply (entrants should contact their service provider for data rates/plans). Entrants should use care and not drive or operate machinery while entering the Sweepstakes.

Video/Nomination (“User Generated Content” and/or “UGC”) Specifications:

- UGC must depict or represent what was requested by the Sponsor.
- The content provided in the UGC must be truthful and factually correct.
- UGC must not contain the likeness, similarity, or face of any person other than the entrant.

- UGC must not include obscenities or other objectionable material that defames or invades the publicity or privacy rights of any person (living or deceased), or that otherwise infringes upon any third party's personal or proprietary rights.

- UGC must not disparage the goodwill or business reputation of Sponsor.
- Sponsor has the right to disqualify any UGC that does not adhere to the above criteria, that is not reasonably pertinent to the Sweepstakes or is otherwise in violation of these Official Rules as determined by Sponsor in its sole and absolute discretion.

4. Prizes/Odds of Winning: A total of five hundred eleven (511) separate prizes will be awarded in the Sweepstakes. One (1) grand prize will be awarded and consists of \$100,000 awarded either by ACH payment or a wire transfer (actual method determined in Sponsor's sole discretion) and an Every Man Jack x Baker Mayfield PR Kit (\$240 value). The actual items contained in the Every Man Jack x Baker Mayfield PR Kit are selected in Sponsor's sole discretion. The approximate retail value ("ARV") of grand prize: \$100,240. Ten (10) runner-up prizes will be awarded and each consists of Every Man Jack x Baker Mayfield PR Kit (\$240 value) and Nobull Training Kit (Shirt, Shorts, Trainers) (\$240 value). The ARV of each runner-up prize: \$480. Five hundred (500) community prizes will be awarded and each consists of a choice of an Every Man Jack Best Seller Bundle (Sandalwood Bundle or Fresh Bundle; \$34.48 value). The actual items contained in the Every Man Jack Best Seller Bundle are selected in Sponsor's sole discretion. The ARV of each community prize: \$34.48. The community prizes will be awarded to the first five hundred (500) entrants who post a "Put in the Work" video on Instagram (item i in section 3 above). **The total ARV of all the prizes: \$122,280. Odds of winning depend upon the total number of eligible Entries received. Limit one (1) prize per person for the entire Sweepstakes.** Prizes may include a gift card valued between \$35 and \$480 (actual prize awarded in Sponsor's sole discretion and subject to availability). No cash equivalent for a non-cash prize(s) will be available. Gift cards cannot be exchanged/redeemed for cash or combined with any other offer and are subject to stated terms and conditions. The prizes are not transferable. However, Sponsor may, in its sole discretion choose to substitute a non-cash prize (or prize component) of equal or greater value due to unavailability or for any other reason. Sponsor reserves the right, in its sole discretion, to replace any merchandise with a newer model or version of the same; but, in such event, Sponsor will continue to use the value of the "old" (i.e., replaced) item for purposes of calculating the ARV. All expenses associated with the receipt or use of a prize not specifically mentioned as being included (e.g., any requested upgrades/options/substitutions) are excluded and are the sole responsibility of each winner(s). As applicable, prizes will only be mailed/shipped/electronically delivered to persons residing in the U.S. and D.C. All federal, state, or other tax liabilities (including but not limited to income taxes) arising from the Sweepstakes or award of a prize will be the sole responsibility of each winner. If a prize value is \$2,000 or more, winner(s) will be issued an IRS Form 1099-MISC from the Sponsor(s) or Sponsor's designee for the total ARV of the prize won (as stated herein) in the calendar year won. Any depiction of the prize(s) in promotional materials or otherwise is for illustrative purposes only. Final eligibility for the award of any prize is subject to eligibility verification as set forth in these Official Rules. The Sweepstakes Administrator is not the supplier or guarantor of any prize.

5. Drawing: Eleven (11) potential winners will be randomly selected from among all eligible Entries received in a drawing to be held on or about two (2) days after the end date by the Sweepstakes Administrator, an independent compliance organization ("Drawing Date").

6. Notification/Verification: The grand prize and runner-up potential winners will be notified via email (or any combination thereof) at the email address provided on his/her Entry by the Sweepstakes Administrator within approximately three (3) business days from the drawing. The Sweepstakes Administrator will only make two (2) notification attempts to reach a potential winner. If potential winner(s) cannot be reached after two (2) notification attempts; if he/she is found to be ineligible; if he/she does not comply with these Official Rules; or if his/her prize or prize notification is returned as undeliverable, such potential winner(s) will be disqualified and an alternate potential winner(s) may be selected in Sponsor's sole discretion. Community prize winners will be notified by email.

Potential grand prize winner(s) will be required to electronically sign and return an unmodified Affidavit of Eligibility, a Liability Release, (where legal) a Publicity Release (collectively "Affidavit/Release"), an IRS W-9 Form, a background authorization form, a copy of his/her legible government-issued photo identification, and any other documentation that Sponsor requires within five (5) days after receipt by potential winner(s) or said person(s) may be disqualified. Documents received electronically have the same force and effect as originals. By completing an Affidavit/Release and IRS W-9 Form, such grand prize winner attests to the provisions stated therein including the accuracy of the information contained therein and compliance with these Official Rules. If a potential grand prize winner is found to be ineligible, he/she does not complete the Affidavit/Release; and/or if he/she does not comply with these Official Rules said potential grand prize winner will be disqualified. The results from the background check must be satisfactory, in Sponsor's sole and absolute discretion. If a background check reveals potential grand prize winner(s) is not a person of good character or standing in their community, has a record of criminal activity, or has been the subject of a restraining order or protective order or otherwise has a past history of substantial anti-social behavior or otherwise represents a danger to persons or property, such potential grand prize winner(s) will be automatically disqualified and an alternate potential grand prize winner(s) of such prize may be selected in Sponsor's sole discretion who must complete the requirements above.

7. Grant of Rights: Sponsor has a nonexclusive license, in perpetuity, to UGC and any ideas, concepts, copyrighted material and trademarks contained in the UGC and any and all rights to the UGC's content become the sole property of Sponsor and may be used by Sponsor without further notice or compensation to entrant. Entrant unconditionally assigns and transfers to Sponsor all rights, title, interest, and claim, which he or she now has, or may in the future have to his/her UGC. Sponsor has the right to modify, edit, adapt, electronically alter, use, assign and/or dispose of such UGC, however it sees fit and for any purpose without any notice or compensation to entrant or any third parties. Entrants grant Sponsor the non-exclusive, royalty-free, irrevocable rights to use, reproduce, copy, publish, display, distribute, perform, translate, adapt, modify, and otherwise exploit the UGC and to incorporate them in other works in any and all markets and media, whether now known or hereafter developed, throughout the universe in perpetuity. Entrants warrant that they have the exclusive right to grant such rights to Sponsor, and that the Sponsor's reproduction, publishing, displaying, and/or other use of the UGC will not infringe on any rights of third parties, including, but not limited to, copyright, trademark, privacy, personal, proprietary, moral, or publicity rights, anywhere in the world. Entrants agree that Sponsor shall have no obligation to copy, publish, display, or otherwise exploit the UGC.

8. Privacy Policy: Any personal information supplied by entrants to the Sponsor or its affiliates will be subject to the Sponsor's Privacy Policy (<https://www.everymanjack.com/policies/privacy-policy>). Thus, except where prohibited by law and Sponsor's Privacy Policy: (1) entry and/or a winner's acceptance of a prize constitutes permission for the Sweepstakes Entities to use the such person's name, address (city and state), UGC, photo(s), likeness, biographical information, statement and voice for advertising/publicity purposes worldwide and in all forms of media (including posting on the Hub and social media channels) in perpetuity, without further notice to or compensation in connection with the Sweepstakes or the prize awarded; and (2) the Sponsor has the right to modify, edit, adapt, electronically alter, use, assign and/or dispose of such Entries however it sees fit and for any purpose without any notice or compensation to an Entrant or any third parties. Entrants understand, agree, and consent that any personally identifiable information provided to the Sweepstakes Administrator may be retained and used for the purposes of this Sweepstakes (including but not limited to any applicable record keeping, tax forms, state registrations, and/or any prize fulfillment related obligations). 9. General Conditions: The Sweepstakes is governed by all applicable federal, state, and local laws, and by these Official Rules. By entering the Sweepstakes, each entrant agrees and acknowledges to be bound by these Official Rules, as well as the decisions of the Sponsor/Sweepstakes Administrator which are final and binding in all respects; to waive any rights to claim ambiguity with these Official Rules; to indemnify and hold harmless the Sweepstakes Entities from any and all liability resulting or arising from the Sweepstakes or the use of any submitted Entry; and to release all rights to bring any claim, action, or proceeding against the Sweepstakes Entities. Once submitted, Entries become the sole property of Sponsor and will not be returned. Sponsor reserves the right, in its sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the Sweepstakes; to be acting in violation of the Official Rules; or to be acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten, or harass any other person. Any person attempting to defraud or in any way tamper with this Sweepstakes may be prosecuted and will be ineligible for a prize. If, for any reason, the Sweepstakes is not capable of running as originally planned, the Sponsor in its sole discretion, reserves the right to cancel, suspend, or modify the Sweepstakes or any portion(s) thereof and instruct the Sponsor's designee(s) to conduct the drawing(s) and award the prize(s) from all salvageable eligible Entries received prior to and/or after (as appropriate) the action taken by Sponsor or award the prize(s) in a manner that is fair and equitable. Notice of such action by the Sponsor will be posted at the Hub as well as any other applicable social media platforms. In case of a dispute over the identity of an entrant who submitted a winning Entry, the authorized account holder of the email address/social media account associated with that Entry will be deemed the Entrant. Said person must be the Entrant, comply with these Official Rules, be the person who completed the act of entering, and, in Sponsor's sole discretion, may be required to provide proof of ownership of the email account/social media account.

Disclaimers: The Sweepstakes Entities are not responsible or liable for Entries that are entered by other than human means (such as by an automated computer program or any non-human mechanism, entity, or device), in excess of the stated limit, or for Entries that are illegible, late, tampered with, forged, incomplete, misdirected, deleted, damaged, lost, misplaced, stolen, destroyed, dropped, inaccessible, corrupted, jumbled, or otherwise not in compliance with these Official Rules and such Entries will be disqualified. By entering the Sweepstakes, each entrant agrees and acknowledges that Sweepstakes Entities shall have no responsibility or liability (including, but not limited to, liability for any property loss, damage, personal injury, or death) in connection with: participation in this Sweepstakes; human error; incorrect or inaccurate transcription of Entry Information; acceptance/possession, use/misuse, and or defects of a prize awarded herein; typographical errors in the promotional material; any technical malfunctions of the telephone network, computer online system, computer dating mechanism, computer equipment, software, or internet service provider(s); interruption or inability to access (or Sponsor's/Sweepstakes Administrator's inability to access) the Sweepstakes, the Hub or online service via the internet due to hardware or software compatibility problems; wireless network dead zones or obstructions; any damage to an entrant's (or any third person's) computer/mobile device and/or its contents related to or resulting from any part of this Sweepstakes or from entering or downloading/uploading materials/software in connection with the Sweepstakes; any lost/delayed data transmissions, omissions, interruptions, defects or any other error's or malfunctions, fraudulent (including unauthorized) gift card uses made with lost, stolen, misplaced, or misappropriated gift cards, incomplete (including inaccurate) gift card database information and cancelled gift card uses due to incomplete (including inaccurate) database information or for any reason even if caused by the negligence of one of the Sweepstakes Entities. The failure of the Sponsor to comply with any provision of these Official Rules due to an act of God, hurricane, war, fire, riot, strikes, epidemics, pandemics, demonstrations, earthquake, terrorism, act of public enemies, actions of governmental authorities outside of the control of Sponsor (excepting compliance with applicable codes and regulations) or other force majeure event will not be considered a breach of these Official Rules.

11. GOVERNING LAW, JURISDICTION, ARBITRATION: Any controversy or claim arising out of or relating to (i) the Sweepstakes, (ii) the awarding or redemption of a prize, and/or (iii) the determination of the scope or applicability of these Official Rules or their enforcement or interpretation, shall be governed by and construed in accordance with the substantive laws of the U.S. State of California without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws. Any controversy or claim arising out of or relating to this agreement, its enforcement, arbitrability or interpretation shall be submitted to final and binding arbitration, to be held in Marin County, California, U.S. before a single arbitrator, in accordance with California Code of Civil Procedure §§ 1280 et seq. The arbitrator shall be selected by mutual agreement of Sponsor and the Entrant(s) bringing forth the controversy or claim, which to the extent permissible must be brought individually and not as part of a class/group (collectively the "Parties") or, if the Parties cannot agree, then by striking from a list of arbitrators supplied by the American Arbitration Association or JAMS/Endispute. The arbitration shall be a confidential proceeding, closed to the general public. The arbitrator shall issue a written opinion stating the essential findings and conclusions upon which the arbitrator's award is based. The Parties will share equally in payment of the arbitrator's fees and arbitration expenses and any other costs unique to the arbitration hearing (recognizing that each side bears its own deposition, witness, expert and attorneys' fees, and other expenses to the same extent as if the matter were being heard in court).
